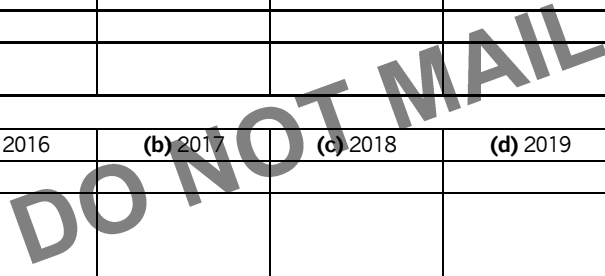

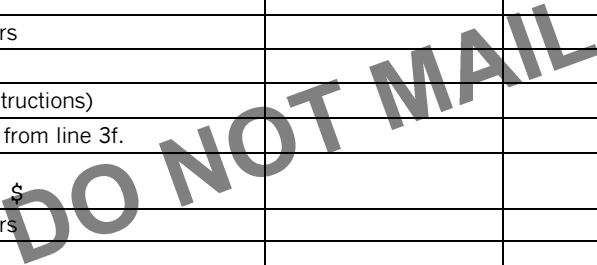

advocacy. Information about how best to navigate the publishing industry is often opaque. The Word provides valuable resource guides and hosts workshops with industry leaders who share vital information with participants. Past workshop topics include: understanding the manuscript submission process; strategies for discussing pay and advances; and ask anything sessions. The number of publishing industry discussions in which the Word participated or facilitated has grown by 200% since the organization's inception. Examples include, developing a dedicated equity discussion as a key introductory anchor at the annual Denver Publishing Institute, keynote address at the 2019 Red Pencil Editor's Conference, as well as a dedicated equitable publishing session within the Regis University MFA program.
